

Privacy Policy

The Bazin Technologies website is owned by Bazin Technologies, which is a controller of your personal data.

We have adopted this privacy policy, which determines how we process the information collected by Bazin Technologies, also providing the reasons why we need to collect certain personal data about you. Therefore, you should read this privacy policy before using the Bazin Technologies website.

We take care of your personal data and are committed to ensuring its confidentiality and security.

The personal information we collect:

When you visit Bazin Technologies, we automatically collect certain information about your device, including information about your web browser, your IP address, your time zone, and some of the cookies installed on your device. Additionally, when you browse the site, we collect information about the web pages or individual products you view, the websites or search terms that referred you to the site, and how you interact with the site. We refer to this information collected automatically as "device information." Additionally, we may collect personal data that you provide to us (including, but not limited to, name, surname, address, payment information, etc.) when registering in order to execute the contract.

Why do we process your data?

Our top priority is the security of customer data, and as such, we can only process minimal data about users, only to the extent that is absolutely necessary to maintain the website. Automatically collected information is used only to identify potential cases of abuse and to establish statistical information regarding website usage. This statistical information is not otherwise aggregated to identify a particular user of the system.

You can visit the website without telling us who you are or revealing information through which someone could identify you as a specific and identifiable individual. However, if you want to use certain features of the website, or if you want to receive our newsletter or provide other details by filling out a form, you can provide us with personal data, such as your email, first name, last name, city of residence, organization, phone number. You may choose not to provide us with your personal data, but then you may not be able to take advantage of certain features of the website. For example, you will not be able to receive our newsletter or contact us directly from the website. Your rights:
